




FINANCIAL STATEMENTS

ETC Annual Financial Report 2022-2023

Treasurer's Notes:

- ETC's relative fiscal stability, cash reserves and solid investment portfolio enabled focus on providing value to members, with fixed dues and no-cost virtual conferences during the pandemic-impacted years, followed by a successful return to in-person activities—including several regional events and our 2022 conference in Orlando.
- Finance Committee recommended new dues rates for FY23-24, and flat conference registrations for 2023, but expects increases for 2024 to manage cashflow and ensure operational viability amid market volatility and inflation trends.
- AMR's finance team manages day-to-day fiscal operations and prepares monthly reports for the Treasurer & Finance Committee as well as quarterly reports to the Board of Directors—we're grateful for their continued expertise.
- Comprehensive audits were again contracted through Besten & Dieruf, which conducted a thorough independent review and submitted annual tax documents / organizational filings, which were accepted by all agencies.

Finance Committee Annual Report FY22-23

ETC's Finance Committee met periodically throughout the year to review financial reports and investments, create an operating budget, and recommend new membership rates after several years of static pricing. The scalable structure continues to serve members well with tiers to fit each member type. Feedback from constituents was weaved into both the conference and committee budgets, including augmentations for the next annual conference and a new allocation for multiple regional gatherings. Rates for FY23-24 dues were approved by the full board in March 2023, and the new operating budget was adopted in June 2023. Finally, this group created a set of guidelines for accessing investment accounts to streamline future procedures with ETC's reserve funding.

EXECUTIVE OFFICE MANAGEMENT COMMITTEE



The EOMC met quarterly over the 2023 fiscal year and focused on the drafting of the FY2024 AMR Workplan, the 2023 AMR Client Satisfaction Survey, as well as creating committee charter drafts for all of ETC's committees.

The EOMC recommended several new items be added to the FY24 Workplan to aid committees in achieving their goals. AMR will be providing full committee support and assistance with deliverables for the Membership, Professional Development and Resource Advisory committees. Also, AMR will be providing additional support for our regional events which are starting to happen with increasing frequency. These much-needed additions were approved by the Board of Directors and have been incorporated into the FY24 plan.

AMR distributed the annual satisfaction survey to the Board in January 2023 and the survey scores and feedback were very complimentary. AMR has continued to do an outstanding job managing ETC's operations and this is reflected in the results.

During the Spring 2023 In-Person Board Meeting, the EOMC was assigned the task of creating charter documents for all ETC committees to provide guidance to current and future committee members. Complimenting the work of the Bylaws Task Force, these documents will provide definition around purpose, deliverables and other guidelines of committees in a charter format, rather than having committees defined in the Bylaws. This will provide much more flexibility when edits or additions to the guidelines are needed in the future. The EOMC worked on these documents in the last several months of FY23 and will have them finalized in the early weeks of FY24.

IDEA COMMITTEE

The IDEA (Inclusion, Diversity, Equity and Accessibility) Committee had a busy first year! After a summer strategizing session, the group undertook a number of initiatives and projects, beginning with the drafting of an Inclusion Statement that was designed to clearly communicate a welcoming and open organization. During the early Fall, IDEA co-sponsored a professional development session with SCUP fellow Shannon Dowling, who shared her work on designing diverse, equitable and inclusive campus spaces and worked with the Elections committee to author a volunteer FAQ document to clearly state expectations for board, committee and task force members. At the annual conference, IDEA introduced social interaction comfort level stickers and committee members presented and facilitated several DEI-related sessions. Later in the Fall, the committee helped update the ETC Digital Accessibility Statement and submitted a proposed change to the bias incident reporting process. During the winter, IDEA distributed and collected their annual demographic survey and held a workshop for all ETC volunteers and leaders to discuss how to better infuse inclusion, diversity, equity and accessibility into all aspects of the organization. The workshop included some great discussions that went deep and identified some key initiatives to move forward. In the Spring, the committee planned for a chair succession, with Karen Ethier stepping down and Cecile-Anne Sison and Rick Nimtz taking over. Throughout the year, IDEA communicated with the membership through the listserv, once with a pre-conference newsletter and once with a pre-survey email.

Plans are in the works by IDEA for an accessibility training (spearheaded by retired, but very active IDEA member Willie Franklin), along with several initiatives for the 2023 annual conference (ice cream social, IDEA panel, interactions with newcomers).


MEMBERSHIP COMMITTEE

REGIONAL EVENTS

Roger Williams University was thrilled to be chosen to kick off ETC's new regional event initiative! The event, held on February 10, 2023 and sponsored by Audinate, Q-SYS, and Wolfvision, was truly a collaboration among ETC members. Sponsor representatives Kathryn Taub, Shay Lynch, Marta Scoppa and Jason Dovel joined RWU IT's Samantha Marshall and Karen Ethier to plan the event from the beginning. After a networking breakfast, the event's fifty or so attendees were welcomed by ETC President, Donnie Merritt, and RWU CIO, Daryl Ford. The remainder of the day was filled with sponsor and host school presentations, an open discussion of challenges faced at our institutions, and a student panel that many said was the highlight of the event. Optional tours were also offered.
